RESOLUTION NO. 14-08, APPROVE A DEMOLITION AGREEMENT BETWEEN JUNE VANDERSTEEN, TRUSTEE OF THE AUDIE G. LEVENTHAL IRREVOCABLE TRUST DATED MAY 12, 2010, AND THE REDEVELOPMENT AGENCY OF WEST VALLEY CITY

Chief Executive Officer, Wayne Pyle, presented proposed Resolution No. 14-08 that would approve a Demolition Agreement between June Vandersteen, Trustee of the Audie G. Leventhal Irrevocable Trust Dated May 12, 2010, and the Redevelopment Agency of West Valley City.

Mr. Pyle stated the Agency desired to clean up the area surrounding the new Residences at Fairbourne Station prior to those units being marketed in mid-June of this year. The subject property at 2940 South 3650 West had been vacant for several years and various development proposals on that site had not proceeded. He indicated rather than have unsightly, boarded up, and vacant buildings, the Redevelopment Agency presented a shared cost proposal to the owner to expedite demolition. He explained development would occur on that property in the future and tax increment from the development would reimburse the Agency for the cost spent on demolition.

He also reminded that the City Center Redevelopment Plan adopted by the Redevelopment Agency in 2004 outlined development of a dynamic town center. A key component of Fairbourne Station was the development of “class A” apartments. The Residences at Fairbourne Station would begin marketing and inviting resident visits by mid-June. He indicated the Audie G. Leventhal property, a collection of vacant, unsightly professional offices, was in close proximity to the development and the immediate demolition of those buildings would enhance the entire area. He further explained as the Agency proceeded through the phases of Fairbourne Station, this property would become the next focus.

After discussion, Mr. Buhler moved to approve Resolution No. 14-08, a Resolution of the West Valley City Redevelopment Agency Approving a Demolition Agreement between June Vandersteen, Trustee of the Audie G. Leventhal Irrevocable Trust Dated May 12, 2010, and the Redevelopment Agency of West Valley City. Ms. Lang seconded the motion.
