After discussion, Mr. Coleman moved to approve Resolution No. 09-03, a Resolution of the West Valley City Building Authority Adopting a Tentative Budget and Setting Forth Proposed Appropriations for the Support of the Building Authority for the Fiscal Year Commencing July 1, 2009, and Ending June 30, 2010; and Setting June 2, 2009, as the Date for Public Hearing. Mr. Winder seconded the motion.
