10 AN ORDINANCE TO AMEND SECTION 17-1-101 AND REPEAL
11 AND REENACT CHAPTER 17-22 OF TITLE 17 OF THE WEST
12 VALLEY CITY MUNICIPAL CODE REGARDING SOLICITING.
13

14
15 WHEREAS, West Valley City desires to amend Section 17-1-101 and repeal and reenact
16 Chapter 17-22 of Title 17 of the West Valley City Municipal Code in order to provide rules, regulations
17 and standards related soliciting so that the regulations would be placed in an appropriate location in the
18 Code; and
19

20 WHEREAS, state and local governments have a substantial and legitimate interest in protecting
21 citizens from intrusions upon citizens’ Residential privacy, consumer fraud, and deceptive, high-pressure,
22 factually unbalanced, or otherwise unfair consumer sales practices; and
23

24 WHEREAS, religious, political, and other noncommercial speech involving the dissemination of
25 ideas enjoys greater constitutional protection than does commercial speech that merely proposes an
26 economic transaction; and
27

28 WHEREAS, local government police power interests are generally entitled to more weight
29 relative to individual Speech Clause rights when balanced against commercial speech than against
30 religious, political, and other noncommercial speech involving the dissemination of ideas; and
31

32 WHEREAS, the Police Department/Department of Public Safety of the City (hereinafter, the
33 “Department”) has investigated complaints and problems relating to Residential Solicitation within the
34 City, including the following within the last three years:
35

36 **Theft:** the vast majority of the complaints related to theft primarily where the solicitor had access
37 inside the residence. Other reports of theft indicated that solicitors attempted to sell property they had
38 stolen from residents;
39

40 **Harassment:** several reports indicated that solicitors peeked in windows and used other
41 aggressive means, including written and verbal threats of violence, to intimidate consumers into
42 answering the door and/or buying their products; and
43

44 WHEREAS, based upon such investigation the Department has concluded that commercial door-
45 to-door Solicitation within the City has resulted in intrusions upon Residential privacy, consumer fraud,
46 and unfair or aggressive consumer sales practices, and that there is a likelihood that this type of conduct
47 arising out of commercial Residential Solicitation would continue to occur, unless the City takes certain
48 steps to regulate commercial Residential Solicitation; and
49

50 WHEREAS, it is the opinion of the Chief of Police that such problems could be eliminated,
51 mitigated, or otherwise controlled by an ordinance governing

52 Residential Solicitation; and

53
54 **WHEREAS**, the State of Utah has provided for the comprehensive regulation of most forms of
55 charitable Solicitation pursuant to the Utah Charitable Solicitations Act, Utah Code Ann. §13-22-1 et
56 seq., thereby making such regulation to prevent consumer fraud and unfair consumer sales practices
57 unnecessary in case of charitable door-to-door Residential Solicitation; and

58
59 **WHEREAS**, commercial Residential Solicitation generally represents a greater intrusion upon
60 Residential privacy than political, religious, or other noncommercial door-to-door Solicitation involving
61 the dissemination of ideas; and

62
63 **WHEREAS**, commercial Residential Solicitation generally entails a higher incidence of
64 consumer fraud and unfair sales practices than political, religious, or other noncommercial door-to-door
65 Solicitation involving the dissemination of ideas; and

66
67 **WHEREAS**, because commercial Residential Solicitation (a) involves the attempt to complete an
68 economic transaction with the hearer, and (b) often includes aggressive, deceptive, factually unbalanced,
69 or otherwise unfair tactics in an effort to complete an economic transaction, commercial Residential
70 Solicitation entails exceptional risks of intrusion upon Residential privacy, consumer fraud, and unfair
71 consumer sales practices, albeit by a minority of those engaged in this business; and

72
73 **WHEREAS**, because noncommercial Residential Solicitation generally does not involve the
74 attempt to complete an economic transaction with the hearer, such Solicitation presents a diminished risk
75 of use of aggressive, deceptive, factually unbalanced, or otherwise unfair tactics in comparison to
76 commercial Solicitation; and

77
78 **WHEREAS**, the elderly, the poor, and the less educated are particularly vulnerable to consumer
79 fraud and unfair consumer sales practices by commercial Residential Solicitors; and

80
81 **WHEREAS**, consumer fraud and deceptive, high-pressure, factually unbalanced, or otherwise
82 unfair consumer sales practices are significantly less frequent in case of charitable Solicitation and
83 Solicitation occurring as an incident to political, religious, and other noncommercial speech; and

84
85 **WHEREAS**, the average amount of money paid by a Resident in a charitable Solicitation or
86 incident to political, religious, or other noncommercial speech is generally less, and often substantially
87 less, than the amount of money paid by a Resident in a transaction arising out of commercial Residential
88 Solicitation; and

89
90 **WHEREAS**, the transient nature of the business of Residential Solicitation makes it difficult to
91 prosecute or to obtain redress for intrusions upon Residential privacy and fraudulent or otherwise unfair
92 consumer sales practices by Residential Solicitors, because such Solicitors are often non-Residents of the
93 City and often leave the City immediately upon completion of their commercial Residential Solicitation;
94 and

95
96 **WHEREAS**, many companies that employ commercial Residential Solicitors do not conduct
97 accurate, thorough and timely criminal background checks on prospective Solicitors; and

98
99 **WHEREAS**, the City wishes to reassure Residents to the extent reasonably possible consistent
100 with the First Amendment that the commercial Residential Solicitors who work within the City have not
101 been the subject of criminal actions, consumer protection actions, or other legal orders or actions
102 reasonably related to the risk of such Solicitors' intruding upon Residential privacy or committing

103 consumer fraud or other unfair consumer sales practices, by instituting a Registration procedure for
104 commercial Residential Solicitors; and

105
106 **WHEREAS**, the limited law enforcement resources of the City make it impracticable for it to
107 investigate and prosecute consumer fraud actions involving losses of less than \$500, and consumer losses
108 of \$500 or less generally do not entail significant consumer hardship; and

109
110 **WHEREAS**, substantial numbers of City Residents do not desire to listen to or otherwise receive
111 commercial Solicitations; and,

112
113 **WHEREAS**, the ordinance set forth herein directly advances the City's interest in protecting its
114 citizens from intrusions upon Residential privacy, consumer fraud, and other unfair consumer sales
115 practices; and,

116
117 **WHEREAS**, based upon the foregoing information the Council finds that the potential and actual
118 harm to citizens from Residential Solicitation is real, and that the provisions hereinafter set forth will in
119 fact to a material degree alleviate and avoid such harm; and,

120
121 **WHEREAS**, the City Council has examined alternative means and methods of regulating door-
122 to-door Solicitation, including the following:

123
124 (a) A total ban on all Residential Solicitation; and

125
126 (b) A total ban on all commercial Residential Solicitation;

127
128 and has concluded that such alternatives would not adequately protect the City's substantial interests in
129 protecting Residents from consumer fraud and other unfair consumer sales practices in a manner that is
130 consistent with the protection afforded commercial speech under the First Amendment; and

131
132 **WHEREAS**, the City Council has determined that the means chosen as hereinafter set forth are
133 reasonable and narrowly and reasonably tailored to achieve the desired objective of protecting citizens
134 from intrusions upon Residential privacy, consumer fraud, and unfair consumer sales practices, while
135 preserving the rights of others to engage in commercial speech that enjoys certain protection under the
136 First Amendment to the United States Constitution and corresponding state constitutional counterparts;
137 and,

138
139 **WHEREAS**, commercial Residential Solicitors have a broad range of options available to them
140 within West Valley City to gain invitations and audiences with owners and occupants of private
141 Residential property for the purpose of demonstrating their wares and making sales, including advertising
142 for invitations by methods such as radio, television, newspapers, newspaper inserts, billboards, telephone
143 Solicitation, facsimile machines, internet web sites, e-mail, U.S. mail and direct mailing, word-of-mouth,
144 contests of various types, advertising on bus benches, advertisements on moving buses or taxi cabs,
145 yellow pages, Welcome-Wagon type services and public displays at fairs, carnivals and games, to name
146 non-exclusive alternatives available to solicitors other than door-to-door Soliciting; and,

147
148 **WHEREAS**, nothing contained in the following adopted provisions prohibits commercial
149 Residential Solicitation and home sales, which are authorized and permitted in accordance with the
150 following provisions which reasonably regulate the time, place and manner in which home sales can be
151 Solicited without regard to the item being sold or the commercial viewpoints expressed in connection
152 with such sales; and,

154 **WHEREAS**, the City Council finds that it is in the best interests of the Residents of the City to
155 adopt provisions regulating door-to-door commercial Residential Solicitation in the manner hereinafter
156 set forth; and,
157

158 **WHEREAS**, the regulations adopted herein are narrowly drawn and in the judgment of the City
159 Council are not more extensive or expansive than necessary to serve and protect the interests stated; and,
160

161 **WHEREAS**, the City Council of West Valley City, Utah, hereby determines that it is in the best
162 interest of the health, safety and welfare of the citizens of West Valley City to amend Section 17-1-101
163 and repeal and reenact Chapter 17-22 of Title 17 of the West Valley City Municipal Code regarding
164 Soliciting;
165

166 **NOW, THEREFORE, BE IT ORDAINED** by the City Council of West Valley City, Utah, as
167 follows:
168

169 **Section 1. Repealer.** Any provision of the West Valley City Code found to be in conflict with
170 this Ordinance is hereby repealed.

~~17-22-101. PERMIT REQUIREMENTS AND EXEMPTIONS.~~

~~— It shall be unlawful for any person 18 years of age or older to engage in peddling or solicitation activities within West Valley City without first obtaining a permit issued by the Business License Division; provided, however, that the following are exempted from the provisions of this Section:~~

- ~~— (1) Any solicitation made upon premises owned or occupied by an organization upon whose behalf the solicitation is made;~~
- ~~— (2) Any communication by an organization soliciting contributions solely from persons who are members of the organization at the time of such solicitation;~~
- ~~— (3) Any solicitation in the form of a collection at a regular meeting, assembly, or service of a charitable person; or~~
- ~~— (4) Any solicitation for the relief of any person specified by name at the time of the solicitation, where the solicitor represents in each case that the entire amount collected shall be turned over to the named beneficiary.~~

~~17-22-102. PERMIT FOR SPONSORING JUVENILE PEDDLERS.~~

- ~~— (1) No person under the age of 18 shall be permitted to engage in peddling, except as provided in this Section.~~
- ~~— (2) A permit shall be obtained by a sponsoring person, company, or organization for the conduct of any peddling or solicitation activities involving, in whole or in part, a sales force of one or more persons under 18 years of age.~~
- ~~— (3) The sponsor shall be responsible for supervising and controlling the conduct of all persons, including juveniles, peddling under the sponsor's permit.~~
- ~~— (4) The sponsor shall provide to each individual in its sales force a badge or other easily readable form of identification, which identifies the name of the sponsor and the name of the individual. The sponsor shall require all individuals in its sales force to wear such identification so that it is clearly visible at all times when the individuals are peddling or soliciting.~~

~~— Every person subject to the provisions of this Chapter shall file with the Business License Division an application, in writing, on a form to be furnished by the Division, which shall provide the following information:~~

~~— (1) — Proof of age, address, and identification of the applicant, to be provided through the applicant's driver's license, articles of incorporation (for sponsors), or other legally recognized form of identification;~~

~~— (2) — A brief description of the business or activity to be conducted;~~

~~— (3) — The hours and location for which the right to peddle or solicit is desired;~~

~~— (4) — If employed, the name, address, and telephone number of the employer; or if acting as an agent, the name, address, and telephone number of the principal who is being represented, with credentials in written form establishing the relationship and the authority of the employee or agent to act for the employer or principal, as the case may be;~~

~~— (5) — A statement as to whether or not the applicant has been convicted of a felony, misdemeanor, or ordinance violation (other than traffic violations), the nature of the offense or violation, the penalty or punishment imposed, the date when and place where such offense occurred, and other pertinent details thereof; and~~

~~— (6) — Proof of possession of any license or permit that, under federal, state, or local laws or regulations, the applicant is required to have in order to conduct the proposed business, or that, under any such law or regulation, would exempt the applicant from the licensing requirements of this Chapter.~~

~~17-22-104. FEES.~~

~~— At the time the application is filed with the Division, the applicant shall pay to the City a fee to cover the City's costs of processing the application and investigating the facts stated therein. The permit fee shall be as stated in the Consolidated Fee Schedule.~~

~~17-22-105. BOND.~~

~~— All solicitors who require cash deposits or take orders for cash on delivery (C.O.D.) purchases, or who require a contract of agreement to finance the sale of any goods, services, or merchandise for future delivery or services to be performed in the future, shall furnish to the Division a bond in the amount of \$15,000.~~

~~17-22-106. APPLICATION REVIEW AND PERMIT ISSUANCE.~~

~~— (1) — Upon receipt of an application, the Director shall review the application as deemed necessary to ensure the protection of the public health, safety, and general welfare.~~

~~— (2) — If the Director finds the application to be satisfactory, the Director shall endorse his/her approval on the application and shall, upon payment of the prescribed fee, deliver the required permit to the applicant.~~

~~— (3) — The permit shall show the name and address of the permittee, the class of permit issued, the kind of goods or services to be sold or delivered, the date of issuance, and the length of time that the permit shall be in effect. The permit shall also show the permit number and identifying description of any vehicle to be used in carrying on the business for which the permit is issued.~~

~~— (4) — The Division, for a period of two years, shall maintain a record of all permits issued.~~

~~17-22-107. DENIAL OF PERMIT.~~

307 — (1) — Upon review of the application, the Director may refuse to issue a permit to the applicant
308 under this Chapter for any of the following reasons:

309 — (a) The location and time of solicitation or peddling would endanger the safety and welfare
310 of the solicitors, peddlers, or their customers;

311 — (b) An investigation reveals that the applicant falsified information on the application;

312 — (c) The applicant has been convicted of a felony, misdemeanor, or ordinance violation
313 involving a sex offense, trafficking in controlled substances, or any violent acts against
314 persons or property, such conviction being entered within the five years preceding the date of
315 application;

316 — (d) The applicant is a person against whom a judgment based upon, or conviction for, fraud,
317 deceit, or misrepresentation has been entered within the five years immediately preceding the
318 date of application;

319 — (e) There is no proof as to the authority of the applicant to serve as an agent to the principal
320 indicated in the application; or

321 — (f) The applicant has been denied a permit under this Chapter within the immediately past
322 year, unless the applicant can and does show to the satisfaction of the Director that the
323 reasons for such earlier denial no longer exist.

324 — (2) — The Director's disapproval and the reasons for disapproval shall be noted on the application,
325 and the applicant shall be notified that the application is disapproved and that no permit will be issued.
326 Notice shall be mailed to the applicant at the address shown on the application form or at the applicant's
327 last known address.

328

329 **~~17-22-108. PERMIT EXPIRATION.~~**

330

331 — All permits issued under the provisions of this Chapter shall expire one year from the date of
332 issuance, unless an earlier expiration date is noted on the permit.

333

334 **~~17-22-109. POLICE WORK CARD REQUIRED.~~**

335

336 — At the time the permit is issued, each permittee shall obtain a work card from the Police Department,
337 which shall be worn by the permittee in such a way as to be conspicuous at all times while the permittee
338 is soliciting or peddling in the City. The applicant shall pay the fee for the work card, as established in
339 the Consolidated Fee Schedule, in addition to any application fees for the permit.

340

341 **~~17-22-110. PERMIT EXHIBITION.~~**

342

343 — Every person required to obtain a permit under the provisions of this Chapter shall exhibit the permit
344 when requested to do so by any prospective customer, Police Officer, or employee of the Business
345 License Division.

346

347 **~~17-22-111. TRANSFER PROHIBITED.~~**

348

349 — It shall be unlawful for any person other than the permittee to use or wear any permit or badge issued
350 under the provisions of this Chapter.

351

352 **~~17-22-112. ENTRY UPON SIGNED PREMISES UNLAWFUL.~~**

353

354 — It shall be unlawful for any person, whether licensed or unlicensed, while conducting the business of
355 a peddler or solicitor, including charitable solicitations, to enter upon any residential premises in the City
356 where the owner, occupant, or person legally in charge of the premises has posted, at the entry to the
357 premises or at the entry to the principal building on the premises, a sign bearing the words "No Peddlers,"

358 "No Solicitors," or words of similar import.

359

360 ~~17-22-113. HOURS OF SOLICITATION.~~

361

362 — No person, while conducting the activities of a peddler or solicitor, whether licensed or unlicensed,
363 including charitable solicitations, shall enter upon any private property, knock on doors, or otherwise
364 disturb persons in their residences between the hours of 9 p.m. and 9 a.m.

365

366 ~~17-22-114. PERMIT REVOCATION.~~

367

368 — Any permit issued under this Chapter may be revoked or suspended by the Business License Division
369 for any of the following reasons:

370 — (1) — Fraud, misrepresentation, or false statement contained in the application for a permit;

371 — (2) — Fraud, misrepresentation, or false statement made by the permittee in the course of
372 conducting solicitation or peddling activities;

373 — (3) — The conduct of peddling or solicitation activities contrary to the provisions contained in the
374 permit;

375 — (4) — Conviction for any crime involving moral turpitude; or

376 — (5) — The conduct of peddling or solicitation activities in such a manner as to create a public
377 nuisance; constitute a breach of the peace; or endanger the health, safety, or general welfare of the public.

378

379 ~~17-22-115. APPEALS.~~

380

381 — A permittee whose permit is revoked, suspended, or denied may appeal to the License Hearing Board.
382 The Appeals Procedure shall be as provided in Section 17-3-106 of the West Valley City Code.

383

384 ~~17-22-116. CLAIMS OF EXEMPTION.~~

385

386 — Any person claiming to be legally exempt from the regulations set forth in this Chapter, or from the
387 payment of a permit fee, shall cite to the Division the statute or other legal authority under which
388 exemption is claimed and shall present to the Director proof of qualification for such exemption.

391

392 ~~17-22-201. PURPOSE AND INTENT.~~

393

394 — It is the intent of this Chapter:

395 — (1) — To serve and protect the health, safety, and welfare of the general public;

396 — (2) — To establish a uniform set of rules and regulations that are fair and equitable; and

397 — (3) — To enhance the overall safety, appearance, and environment along public streets, pedestrian
398 ways, and other public properties.

399

400 ~~17-22-202. LICENSE REQUIRED.~~

401

402 — It shall be unlawful for any person to engage in the business of vending unless he/she has first
403 obtained a license from the Business License Division. All licenses shall be issued according to
404 regulations established by the Division.

405

406 ~~17-22-203. APPLICATION FOR LICENSE.~~

407

408 — The application for a vending license shall contain all information relevant and necessary to

determine whether a particular license may be issued, including, but not limited to:
— (1) — The applicant's full name, current address, telephone number, and proof of identity;
— (2) — A brief description of the nature, character, and quality of goods, wares, or merchandise to be offered for sale;
— (3) — The specific location, if any, in which the vendor intends to conduct business;
— (4) — If the applicant is employed by another, the name and address of the person, firm, association, organization, company, or corporation; and
— (5) — If a motor vehicle is to be used, a description of the vehicle, together with the motor vehicle registration number and license number.

~~17-22-204. HEALTH INSPECTION CERTIFICATE.~~

— Any application for a vending license to engage in the sale of food or beverages shall require a health permit from Salt Lake County in addition to the regular vending license. The applicant's equipment shall be subject to inspections by the County Health Department at the time of application and at periodic intervals thereafter.

~~17-22-205. ISSUANCE OF LICENSE.~~

— (1) — The Director shall notify the applicant in writing of the City's decision to issue or deny the vending license, not later than thirty 30 days after the applicant has filed a completed application with the Division. Any applicant for a license to sell food and beverages, whose application receives the approval of the county health department, shall be issued both a vending license and a health permit.

— (2) — Each license shall show the name and address of the licensee, the type of license issued, the kind of goods to be sold, the amount of the license fee, the date of issuance, the license number, an identifying description of any vehicle or conveyance used by the licensee plus, where applicable, the motor vehicle registration number. Each license shall also show the expiration date of the license and the vendor's plate number issued by the City.

— (3) — In addition to the vending license and any other permit required by this Chapter, the applicant shall obtain a work card from the Police Department. The applicant shall pay the fee for the work card as established in the Consolidated Fee Schedule, in addition to any application fees for the permit.

— (4) — All licenses, permits, and work cards issued pursuant to this Part are valid for one year, unless suspended or revoked, and shall be both non assignable and non transferable.

~~17-22-206. LICENSE FEES.~~

— Any vendor granted a vending license under this Chapter shall pay the annual license fee established in the Consolidated Fee Schedule.

~~17-22-207. DISPLAY OF WORK CARDS AND OTHER PERMITS.~~

— (1) — Any license or permit issued by the Division shall be carried with the licensee whenever he/she is engaged in vending. Work cards and health permits shall also be properly and conspicuously displayed at all times during the operation of the vending business.

861 sidewalks, roadways, highways, parkways, alleys, parks, as well as the areas surrounding and

862 immediately adjacent to public buildings. "Public Way" also includes areas designated for parking
863 associated with public property.

864 (478) "Pushcart" means any wheeled vehicle approved by the Business Licensing Division in
865 accordance with this Chapter, designed for carrying property and for being pushed by a person without
866 the assistance of a motor or motor vehicle.

867 (489) "Racetrack" means a facility consisting of a paved roadway used primarily for the sport
868 of automobile racing. A racetrack may include seating, concession areas, suites, and parking facilities, but
869 does not include accessory offices, residences, or retail facilities. This definition shall also include any
870 facility used for driving automobiles under simulated racing or driving conditions (test tracks,
871 "shakedown" tracks, or other similar facilities), but which does not include seating, concession areas, or

896 merchants, not more than one of whom is licensed as a temporary merchant, display any goods, wares, or
897 services at a location in the City for the purpose of sale or soliciting orders to be filled in the future for
898 financial gain or profit.

899 (523) "Sidewalk" means all of that area legally open to public use as a pedestrian public way
900 between the curb line and the legal building line of the abutting property.

901 ~~(53) "Solicitor" means any person who goes upon the premises of any private residence in the~~

 977 offering and exposing them for sale, or making sales and delivering articles to purchasers; or who,
 978 without traveling from place to place, exhibits, displays, sells, or offers for sale such products while on

17-22-101. PURPOSE.

1056

(1) Residents of the City have an inalienable interest in their personal safety, well-being, and privacy in their residences, as well as their ability to provide or receive information regarding matters of personal belief, political or charitable activities, and goods and services lawfully in commerce. The City has a substantial interest in protecting the well-being, tranquility, personal safety, and privacy of its citizens, which includes the ability to protect citizens from unwanted intrusions upon residential property. The City also has a substantial interest in protecting citizens from fraud or otherwise unfair consumer sales practices as well as criminal activity.

(2) There must be a balance between these substantial interests of the City and its citizens,

1065 and the effect of the regulations in this Chapter on the rights of those who are regulated. Based on the
1066 collective experiences of City officials derived from regulating business activity, protecting persons and
1067 property from criminal conduct, responding to the inquiries of citizens regarding Door-to-Door
1068 Solicitation, the experience of its law enforcement officers and those affected by Door-to-Door
1069 canvassing and Solicitation, as well as judicial decisions outlining the boundaries of constitutional
1070 protections afforded and denied persons seeking to engage in Door-to-Door Solicitation, the City adopts
1071 this Chapter to promote the City's substantial interests in:

- 1072 (a) respecting citizen's decisions regarding privacy in their residences;
- 1073 (b) protecting persons from criminal conduct;
- 1074 (c) providing equal opportunity to Advocate for and against Religious Belief,
1075 Political Position, or Charitable Activities; and
- 1076 (d) permitting truthful and non-misleading Door-to-Door Solicitation regarding
1077 lawful Goods or Services in intrastate or interstate commerce.

1078 (3) The City finds that the procedures, rules and regulations set forth in this Chapter are
1079 narrowly tailored to preserve and protect the City interests referred to herein while at the same time
1080 balancing the rights of those regulated.

1082 **17-22-102. NO OTHER CITY LICENSE OR APPROVAL REQUIRED.**

1083
1084 (1) Registered Solicitors and persons exempt from Registration need not apply for, nor
1085 obtain, any other license, permit, or registration from the City to engage in Door-to-Door Solicitation.

1086 (2) Any Business licensed by the City under another City Ordinance that uses employees,
1087 independent contractors, or agents for Door-to-Door Solicitation in an effort to provide any tangible or
1088 intangible benefit to the Business, shall be required to have such Solicitors obtain a Certificate, unless
1089 otherwise exempt from Registration.

1090 (3) Those Responsible Persons or Entities associated with Registered Solicitors need not
1091 apply for, nor obtain, any other license, permit, or registration from the City, provided they do not

1099 For the purposes of this Chapter, the following definitions shall apply:

1100 (1) "Advocating" means conduct, including speech, intended to inform, promote, or support
1101 Religious Belief, Political Position, or Charitable Activities.

1103 (3) "Appellant" means the person or entity appealing the denial or suspension of a

1112 Application, of either: (1) a Utah Department of Public Safety Bureau of Criminal Identification verified
1113 criminal history report personal to the Applicant; or (2) verification by the Utah Department of Public
1114 Safety Bureau of Criminal Identification that no criminal history rising to the level of a Disqualifying
1115 Status exists for the Applicant.

- 1116 (7) "Certificate" means a temporary, annual, or renewal Certificate permitting Door-to-Door
1117 Solicitation in the City applied for or issued pursuant to the terms of this Chapter.
- 1118 (8) "Competent Individual" means a person claiming to be at least eighteen (18) years of age
1119 and of sufficiently sound mind and body to be able to engage in rational thought, conversation and
1120 conduct.
- 1121 (9) "Completed Application" means a fully completed Application Form, a BCI, two copies
1122 of the original identification relied on by the Applicant to establish Proof of Identity and the tendering of
1123 fees.
- 1124 (10) "Criminally Convicted" means, for the purpose of this Chapter, the final entry of a
1125 conviction, whether by a plea of no contest, guilty, entry of a judicial or jury finding of guilt, which has
1126 not been set aside on appeal or pursuant to a writ of habeas corpus. The criminal conviction is that offense
1127 of which the Applicant or Registered Solicitor was convicted, without regard to the reduced status of the
1128 charge after completion of conditions of probation or parole, and specifically includes charges dismissed
1129 pursuant to a plea in abeyance or diversion agreement.
- 1130 (11) "Disqualifying Status" means anything specifically defined in this Chapter as requiring
1131 the denial or suspension of a Certificate, and any of the following:
- 1132 (a) The Applicant or Registered Solicitor has been Criminally Convicted of: (i)
1133 felony homicide, (ii) physically abusing, sexually abusing, or exploiting a minor
1134 or Vulnerable Adult (iii) the sale or distribution of controlled substances, (iv)
1135 sexual assault of any kind, or (v) a crime involving dishonesty or false statements
1136 within the meaning of Rule 609(a)(2), Utah Rules of Evidence;
 - 1137 (b) Criminal charges currently pending against the Applicant or Registered Solicitor
1138 for: (i) felony homicide, (ii) physically abusing, sexually abusing, or exploiting a
1139 minor or Vulnerable Adult, (iii) the sale or distribution of controlled substances,
1140 (iv) sexual assault of any kind, or (v) a crime involving dishonesty or false
1141 statements within the meaning of Rule 609(a)(2), Utah Rules of Evidence;
 - 1142 (c) The Applicant or Registered Solicitor has been Criminally Convicted of a felony
1143 within the last ten (10) years;
 - 1144 (d) The Applicant or Registered Solicitor has been incarcerated in a federal or state
1145 prison within the past five (5) years;
 - 1146 (e) The Applicant or Registered Solicitor has been Criminally Convicted of a
1147 misdemeanor within the past five (5) years involving a crime of: (i) moral
1148 turpitude, or (ii) violent or aggravated conduct involving persons or property;
 - 1149 (f) A Final Civil Judgment been entered against the Applicant or Registered
1150 Solicitor within the last five (5) years indicating that: (i) the Applicant or
1151 Registered Solicitor had either engaged in fraud, or intentional misrepresentation,
1152 or (ii) that a debt of the Applicant or Registered Solicitor was non-dischargeable

1155 court, penal institution, or governmental entity, including being under house

 - 1157 (h) The Applicant or Registered Solicitor has an outstanding arrest warrant from any
1158 jurisdiction; or
 - 1159 (i) The Applicant or Registered Solicitor is currently subject to a protective order
1160 based on actual or threatened physical or sexual abuse issued by a court of
1161 competent jurisdiction.
- 1162 (12) "Door to Door Solicitation" means the practice of engaging in or attempting to engage in
1163 conversation with any person at a Residence, whether or not that person is a Competent Individual, while
1164 making or seeking to make or facilitate a Home Solicitation Sale, or attempting to further the sale of
1165 Goods and or Services.
- 1166 (13) "Home Solicitation Sale" means to make or attempt to make a Sale of Goods or Services

- 1167 by a Solicitor at a Residence by means of Door-to-Door Solicitation, regardless of
- 1168 (a) the means of payment or consideration used for the purchase;
- 1169 (b) the time of delivery of the Goods or Services; or
- 1170 (c) the previous or current classification of the Solicitor as a solicitor, peddler,
- 1171 hawker, itinerant merchant, or similar designation.
- 1172 (14) “No Solicitation Sign” means a reasonably visible and legible sign that states “No
- 1173 Soliciting,” “No Solicitors,” “No Salespersons,” “No Trespassing,” or words of similar import.
- 1174 (15) “Registered Solicitor” means any person who has been issued a current Certificate by the
- 1175 City.
- 1176 (16) “Registration” means the process used by the City Licensing Officer to accept a
- 1177 Completed Application and determine whether a Certificate will be denied, granted, or suspended.
- 1178 (17) “Religious Belief” means any sincerely held belief, or information for, against, or in
- 1179 conjunction with, any theistic, agnostic, or atheistic assumption, presumption or position, or religious
- 1180 doctrine, dogma, or practice regardless of whether or not the belief or information is endorsed by any
- 1181 other person or public or private entity.
- 1182 (18) “Responsible Person or Entity” means that person or Entity responsible to provide the

- 1201 (b) Seeking to obtain prospective customers to apply for or to purchase insurance,
- 1202 subscriptions to publications, or publications;
- 1203 (c) Seeking to obtain contributions of money or any other thing of value for the
- 1204 benefit of any person or Entity;
- 1205 (d) Seeking to obtain orders or prospective customers for Goods or Services;
- 1206 (e) Seeking to engage an individual in conversation at a Residence for the purpose of
- 1207 promoting or facilitating the receipt of information regarding Religious Belief,
- 1208 Political Position, Charitable Conduct, or a Home Solicitation Sale; and/or
- 1209 (f) Other activities falling within the commonly accepted definition of Soliciting,
- 1210 such as hawking or peddling.
- 1211 (22) “Solicitor” or “Solicitors” means a person(s) engaged in Door-to-Door Solicitation.
- 1212 (23) “Submitted in Writing” means the information for an appeal of a denial or suspension of
- 1213 a Certificate, submitted in any type of written statement to the City offices by certified, registered,
- 1214 priority, overnight or delivery confirmation mail, facsimile, or hand delivery.
- 1215 (24) “Substantiated Report” means an oral, written, or electronic report:
- 1216 (a) That is submitted to and documented by the City;
- 1217 (b) By any of the following:

- 1218 (i) A Competent Individual who is willing to provide law enforcement or
1219 other City employees with publicly available identification of their name,
1220 address, and any other reliable means of contact;
1221 (ii) City law enforcement or Licensing Officer; or
1222 (iii) Any other regularly established law enforcement agency at any level of
1223 government;
1224 (c) That provides any of the following information regarding a Registered Solicitor:
1225 (i) Documented verification of a previously undisclosed Disqualifying
1226 Status of a Registered Solicitor;
1227 (ii) Probable cause that the Registered Solicitor has committed any act set
1228 forth as a Disqualifying action regardless of whether it has already been
1229 determined to be a Disqualifying act;
1230 (iii) Documented, eye-witness accounts that the Registered Solicitor has
1231 engaged in repeated patterns of behavior that demonstrates failure by the
1232 Registered Solicitor to adhere to the requirements of this Chapter; or
1233 (iv) Probable cause that continued licensing of the Registered Solicitor
1234 creates exigent circumstances that threaten the health, safety, or welfare
1235 of any individuals or entities within the City [I think this may be too
1236 discretionary, resulting in a prior restraint].

1237 (25) "Vulnerable Adult" means an elder adult, or an adult 18 years of age or older who has a
1238 mental or physical impairment which substantially affects that person's ability to:

- 1239 (a) provide personal protection;
1240 (b) provide necessities such as food, shelter, clothing, or medical or other health
1241 care;
1242 (c) obtain services necessary for health, safety, or welfare;
1243 (d) carry out the activities of daily living;
1244 (e) manage the adult's own resources; or
1245 (f) comprehend the nature and consequences of remaining in a situation of abuse,
1246 neglect, or exploitation.

1247 (26) "Waiver" means the written form provided to Applicant by the City wherein Applicant
1248 agrees that City may obtain a name/date of birth BCI background check on the Applicant for licensing
1249 purposes under this Chapter, and which contains Applicant's notarized signature.

1251 **17-22-104. EXEMPTIONS FROM CHAPTER.**

1252
1253 The following are exempt from Registration under this Chapter:

- 1254 (1) Persons specifically invited to a Residence by a Competent Individual prior to the time of
1255 the person's arrival at the Residence;
1256 (2) Persons whose license, permit, certificate or registration with the State of Utah permits
1257 them to engage in Door to Door Solicitation to offer Goods or Services to an occupant of the Residence;
1258 (3) Persons delivering Goods to a Residence pursuant to a previously made order, or persons
1259 providing Services at a Residence pursuant to a previously made request by a Competent Individual;
1260 (4) Persons advocating or disseminating information for, against, or in conjunction with, any
1261 Religious Belief, or Political Position regardless of whether Goods, Services, or any other consideration is
1262 offered or given, with or without any form of commitment, contribution, donation, pledge, or purchase;
1263 and
1264 (5) Persons representing a Charitable Organization. The charitable exemption shall apply to
1265 students Soliciting contributions to finance extracurricular social, athletic, artistic, scientific or cultural
1266 programs, provided that the Solicitation has been approved in writing by the school administration, and
1267 that such student Solicitors carry current picture student identification from the educational institution for
1268 which they are Soliciting.

1269 Those Persons exempt from Registration are not exempt from the duties and prohibitions outlined
1270 in Sections 17-22-117, 17-22-118 and 17-22-119 while Advocating or Soliciting.

1271
1272 **17-22-105. SOLICITATION PROHIBITED.**

1273
1274 Unless otherwise authorized, permitted, or exempted pursuant to the terms and provisions of this
1275 Chapter, the practice of being in and upon a private Residence within the City by Solicitors, for the
1276 purpose of Home Solicitation Sales or to provide Goods or Services, is prohibited and is punishable as set
1277 forth in this Chapter.

1278
1279 **17-22-106. REGISTRATION OF SOLICITORS.**

1280
1281 Unless otherwise exempt under this Chapter, all persons desiring to engage in Door-to-Door
1282 Solicitation within the City, prior to doing so, shall submit a Completed Application to the Licensing
1283 Officer and obtain a Certificate.

1284
1285 **17-22-107. APPLICATION FORM.**

1286
1287 The Licensing Officer shall provide a standard Application Form for use for the Registration of
1288 Solicitors. Upon request to the Licensing Officer, or as otherwise provided, any person or Entity may
1289 obtain in person, by mail, or facsimile, a copy of this Application Form. Each Application Form shall
1290 require disclosure and reporting by the Applicant of the following information, documentation, and fee:

1291 (1) Review of Written Disclosures. An affirmation that the Applicant has received and
1292 reviewed the disclosure information required by this Chapter.

1293 (2) Contact Information.

1294 (a) Applicant's true, correct and legal name, including any former names or aliases
1295 used during the last ten (10) years;

1296 (b) Applicant's telephone number, home address and mailing address, if different;

1297 (c) If different from the Applicant, the name, address, and telephone number of the
1298 Responsible Person or Entity; and

1299 (d) The address by which all notices to the Applicant required under this Chapter are
1300 to be sent.

1301
1302 (3) Proof of Identity. An in-person verification by the Licensing Officer of the Applicant's
1303 true identity by use of any of the following which bear a photograph of said Applicant:

1304 (a) A valid drivers license issued by any State;

1305 (b) A valid passport issued by the United States;

1306 (c) A valid identification card issued by any State;

1307 (d) A valid identification issued by a branch of the United States military.

1308 Upon verification of identity, the original identification submitted to establish Proof of Identity shall be
1309 returned to the Applicant.

1310 (4) Proof of Registration with Department of Commerce. The Applicant shall provide proof
1311 that either the Applicant, or the Responsible Person or Entity, has registered with the Utah State
1312 Department of Commerce;

1313 (5) Special Events Sales Tax Number. The Applicant shall provide a special events sales tax
1314 number for either the Applicant, or for the Responsible Person or Entity for which the Applicant will be
1315 soliciting;

1316 (6) Marketing Information.

1317 (a) The Goods or Services offered by the Applicant, including any commonly
1318 known, registered or trademarked names;

1319 (b) Whether the Applicant holds any other licenses, permits, registrations, or other

1320 qualifications required by federal or state law to promote, provide, or render
1321 advice regarding the offered Goods or Services.

1322 (7) BCI Background Check. The Applicant shall provide an original or a copy of a BCI
1323 background check as defined in 17-22-103; and a signed copy of a Waiver whereby Applicant agrees to
1324 allow the City to obtain a name/date of birth BCI background check on Applicant for purposes of
1325 enforcement of this Chapter.

1326 (8) Responses to Questions Regarding “Disqualifying Status.” The Applicant shall be
1327 required to affirm or deny each of the following statements on the Application Form:

1328 (a) Has the Applicant been Criminally Convicted of: (I) felony homicide, (ii)
1329 physically abusing, sexually abusing, or exploiting a minor, or Vulnerable Adult
1330 (iii) the sale or distribution of controlled substances, (iv) sexual assault of any
1331 kind, or (v) a crime involving dishonesty or false statements within the meaning
1332 of Rule 609(a)(2), Utah Rules of Evidence;

1333 (b) Are any criminal charges currently pending against the Applicant for: (i) felony
1334 homicide, (ii) physically abusing, sexually abusing, or exploiting a minor, or
1335 Vulnerable Adult (iii) the sale or distribution of controlled substances, (iv) sexual
1336 assault of any kind, or (v) a crime involving dishonesty or false statements within
1337 the meaning of Rule 609(a)(2), Utah Rules of Evidence;

1338 (c) Has the Applicant been Criminally Convicted of a felony within the last ten (10)
1339 years;

1340 (d) Has the Applicant been incarcerated in a federal or state prison within the past
1341 five (5) years;

1342 (e) Has the Applicant been Criminally Convicted of a misdemeanor within the past
1343 five (5) years involving a crime of: (I) moral turpitude, or (ii) violent or
1344 aggravated conduct involving persons or property;

1345 (f) Has a Final Civil Judgment been entered against the Applicant within the last
1346 five (5) years indicating that: (I) the Applicant had either engaged in fraud, or
1347 intentional misrepresentation, or (ii) that a debt of the Applicant was non-
1348 dischargeable in bankruptcy pursuant to 11 U.S.C. § 523(a)(2), (a)(4), (a)(6), or
1349 (a)(19);

1350 (g) Is the Applicant currently on parole or probation to any court, penal institution,
1351 or governmental entity, including being under house arrest or subject to a
1352 tracking device;

1353 (h) Does the Applicant have an outstanding arrest warrant from any jurisdiction; or

1354 (i) Is the Applicant currently subject to a protective order based on actual or
1355 threatened physical or sexual abuse issued by a court of competent jurisdiction.

1356 (9) Fee. The Applicant shall pay such fees as determined applicable by the City, which shall
1357 not exceed the reasonable cost of processing the application and issuing the Certificate and/or
1358 Identification Badge.

1359 (10) Execution of Application. The Applicant shall execute the Application Form, stating
1360 upon oath or affirmation, under penalty of perjury, that based on the present knowledge and belief of the
1361 Applicant, the information provided is complete, truthful and accurate.

1363 **17-22-108. WRITTEN DISCLOSURES.**

1364
1365 The Application Form shall be accompanied by written disclosures notifying the Applicant of the
1366 following:

1367 (1) The Applicant’s submission of the Application authorizes the City to verify information
1368 submitted with the Completed Application including:

1369 (a) the Applicant’s address;

1370 (b) the Applicant’s and/or Responsible Person or Entity’s state tax identification and

- 1371 special use tax numbers, if any; and
1372 (c) the validity of the Applicant's Proof of Identity;
- 1373 (2) The City may consult any publicly available sources for information on the Applicant,
1374 including but not limited, to databases for any outstanding warrants, protective orders, or civil judgments;
- 1375 (3) Establishing Proof of Identity is required before Registration is allowed;
- 1376 (4) Identification of the fee amount that must be submitted by Applicant with a Completed
1377 Application;
- 1378 (5) The Applicant must submit a BCI background check with a Completed Application;
- 1379 (6) To the extent permitted by State and/or federal law, the Applicant's BCI background
1380 check shall remain a confidential, protected, private record not available for public inspection;
- 1381 (7) The City will maintain copies of the Applicant's Application Form, Proof of Identity, and
1382 Identification Badge. These copies will become public records available for inspection on demand at the
1383 City offices whether or not a Certificate is denied, granted, or renewed;
- 1384 (8) The criteria for Disqualifying Status, denial, or suspension of a Certificate under the
1385 provisions of this Chapter.
- 1386 (9) That a request for a temporary Certificate will be granted or denied the same business day
1387 that a Completed Application is submitted.
- 1388

1389 **17-22-109. WHEN REGISTRATION BEGINS.**

1390

1391 The Licensing Officer shall not begin the Registration process unless the Applicant has submitted
1392 a Completed Application. The original identification submitted to establish Proof of Identity shall be
1393 returned after the Licensing Officer verifies the Applicant's identity. A copy of the identification may be
1394 retained by the Licensing Officer. If an original B.C.I. background check is submitted by the Applicant,
1395 the Licensing Officer shall make a copy of the B.C.I. and return the original to the Applicant.

1396

1397 **17-22-110. ISSUANCE OF CERTIFICATES.**

1398

1399 The Licensing Officer shall review the Completed Application submitted by the Applicant and
1400 issue a Certificate in accordance with the following:

- 1401 (1) Temporary Certificate.
- 1402 (a) A temporary Certificate shall issue allowing the Applicant to immediately begin
1403 Door-to-Door Solicitation upon the following conditions:
- 1404 (i) Applicant's submission of a Completed Application;
- 1405 (ii) Applicant's submission of the required fee;
- 1406 (iii) Applicant establishes Proof of Identity;
- 1407 (iv) the Applicant's representations on the Application Form do not
1408 affirmatively show a Disqualifying Status;
- 1409 (iv) the B.C.I. does not affirmatively show a Disqualifying Status; and
- 1410 (vi) the Applicant has not previously been denied a Certificate by the City, or
1411 had a Certificate revoked for grounds that still constitute a Disqualifying
1412 Status under this Chapter.
- 1413 (b) A temporary Certificate will automatically expire after twenty-five (25) calendar
1414 days from issuance, or upon grant or denial of an annual Certificate, whichever
1415 period is shorter.
- 1416 (2) Annual Certificate. Within twenty-five (25) calendar days of the issuance of a
1417 temporary Certificate the City shall:
- 1418 (a) Take any and all actions it deems appropriate to verify the truthfulness and
1419 completeness of the information submitted by the Applicant, including, but not
1420 limited to those disclosed with the Application Form;
- 1421 (b) Issue written notice to the Applicant and the Responsible Person or Entity, if any,

1422 that the Applicant either:
1423 (i) will be issued an annual Certificate, eligible for renewal one year from
1424 the date of issuance of the temporary Certificate; or
1425 (ii) will not be issued an Annual Certificate for reasons cited in Section 17-
1426 22-114 of this Chapter.

1427 (3) Renewal Certificate. An annual Certificate shall be valid for one year from the date of
1428 issuance of the temporary Certificate and shall expire at midnight on the anniversary date of issuance.
1429 Any annual Certificate that is not suspended, revoked, or expired may be renewed upon the request of the
1430 Registered Solicitor and the submission of a new Completed Application and payment of the Fee, unless
1431 any of the conditions for the denial, suspension or revocation of a Certificate are present as set forth in
1432 section 17-22-114, or a Disqualifying Status exists.

1433
1434 **17-22-111. FORM OF CERTIFICATE AND IDENTIFICATION BADGE.**

1435
1436 (1) Certificate Form. Should the Licensing Officer determine that the Applicant is entitled to
1437 a Certificate, the Licensing Officer shall issue a Certificate to the Applicant. The Certificate shall list the
1438 name of the Registered Solicitor and the Responsible Person or Entity, if any, and the date on which the
1439 Certificate expires. The Certificate shall be dated and signed by the License Officer. The Certificate
1440 shall be carried by the Registered Solicitor at all times while Soliciting in the City.

1441 (2) Identification Badge. With both the temporary and annual Certificates, the City shall
1442 issue each Registered Solicitor an Identification Badge that shall be worn prominently on his or her
1443 person while Soliciting in the City. The Identification Badge shall bear the name of the City and shall
1444 contain:

- 1445 (a) the name of the Registered Solicitor;
- 1446 (b) address and phone number of the Registered Solicitor, or the name, address, and
1447 phone number of the Responsible Person or Entity is provided;
- 1448 (c) a recent photograph of the Registered Solicitor; and
- 1449 (d) the date on which the Certificate expires.

1450
1451 **17-22-112. MAINTENANCE OF REGISTRY.**

1452
1453 The Licensing Officer shall maintain and make available for public inspection a copy or record of
1454 every Completed Application received and the Certificate or written denial issued by the City. The
1455 Applicant's BCI background check shall remain a confidential, protected, private record not available for
1456 public inspection. The Licensing Officer may furnish to the head of the City's law enforcement agency a
1457 listing of all Applicants, those denied, and those issued a Certificate.

1458
1459 **17-22-113. NON-TRANSFERABILITY OF CERTIFICATES.**

1460
1461 Certificates shall be issued only in the name of the Applicant and shall list the Responsible Party
1462 or Entity, if any. The Certificate shall be non-transferable. A Registered Solicitor desiring to facilitate or
1463 attempt to facilitate Home Solicitation Sales with different: (a) Goods or Services; or (b) Responsible
1464 Person or Entity, from those designated in the originally submitted Completed Application, shall submit a
1465 written change request to the Licensing Officer. A new Certificate based on the amended information
1466 shall issue for the balance of time remaining on the Solicitor's previous Certificate before the amendment
1467 was filed so long as no Disqualifying Status exists. Before the new Certificate is given to the Registered
1468 Solicitor, the Registered Solicitor shall obtain a revised Identification Badge from the City, after payment
1469 of the Fee for the Identification Badge.

1470
1471 **17-22-114. DENIAL, SUSPENSION OR REVOCATION OF A CERTIFICATE OF**
1472 **REGISTRATION.**

- 1473
1474 (1) Denial. Upon review, the Licensing Officer shall refuse to issue a Certificate to an
1475 Applicant for any of the following reasons:
1476 (a) Denial of Temporary Certificate.
1477 (i) the Application Form is not complete;
1478 (ii) the Applicant fails to (1) establish Proof of Identity, (2) provide a B.C.I.
1479 or (3) pay the Fees;
1480 (iii) the Completed Application or B.C.I. indicates that the Applicant has a
1481 Disqualifying Status; or
1482 (iv) The Applicant has previously been denied a Certificate by the City, or
1483 has had a Certificate revoked for grounds that still constitute a
1484 Disqualifying Status under this chapter.
1485 (b) Denial of Annual Certificate.
1486 (i) The information submitted by the Applicant at the time of the granting of
1487 the temporary Certificate is found to be incomplete or incorrect;
1488 (ii) Since the submission of the Completed Application, the Applicant is
1489 subject to a previously undisclosed or unknown Disqualifying Status;
1490 (iii) Failure to complete payment of the Fees;
1491 (iv) Since the submission of the Application, the City has received a
1492 Substantiated Report regarding the past or present conduct of the
1493 Applicant;
1494 (v) Since the submission of the Application, the City or other governmental
1495 entity has either Criminally Convicted or obtained a civil injunction
1496 against the Applicant for violating this Chapter or similar Federal, State,
1497 or municipal laws in a manner rising to the level of a Disqualifying
1498 Status; or
1499 (vi) Since the submission of the Application, a Final Civil Judgment was
1500 entered against the Applicant indicating that: (I) the Applicant had either
1501 engaged in fraud, or intentional misrepresentation, or (ii) that a debt of
1502 the applicant was non-dischargeable in bankruptcy pursuant to 11 U.S.C.
1503 § 523(a)(2), (a)(4), (a)(6), or (a)(19).
1504 (c) Denial of Annual Certificate Renewal.
1505 (i) The information submitted by the Applicant when seeking renewal of a
1506 Certificate is found to be incomplete or incorrect;
1507 (ii) Since the submission of the renewal Application, the Applicant is subject
1508 to a previously undisclosed or unknown Disqualifying Status;
1509 (iii) Failure to complete payment of the Fees;
1510 (iv) Since the submission of the Application or granting of a Certificate, the
1511 City has received a Substantiated Report regarding the past or present
1512 conduct of the Solicitor;
1513 (v) The City or other governmental entity has either Criminally Convicted or
1514 obtained a civil injunction against the Applicant for violating this
1515 Chapter or similar Federal, State, or municipal laws in a manner rising to
1516 the level of a Disqualifying Status; or
1517
1518 (vi) Since the submission of the Application, a Final Civil Judgment was
1519 entered against the Applicant indicating that: (i) the Applicant had either
1520 engaged in fraud, or intentional misrepresentation, or (ii) that a debt of
1521 the applicant was non-dischargeable in bankruptcy pursuant to 11 U.S.C.
1522 § 523(a)(2), (a)(4), (a)(6), or (a)(19).
1523 (2) Suspension or Revocation. The City shall either suspend or revoke a Certificate when

1524 any of the reasons warranting the denial of a Certificate occurs.
1525 (3) Notice of Denial or Suspension. Upon determination of the Licensing Officer to deny an
1526 Applicant's Completed Application or to suspend a Registered Solicitor's Certificate, the City shall cause
1527 written notice to be sent to the Applicant or Registered Solicitor by the method indicated in the
1528 Completed Application. The Notice shall specify the grounds for the denial or suspension, the
1529 documentation or information the City relied on to make the decision, the availability of the
1530 documentation for review by Applicant upon one (1) business day's notice to the City, and the date upon
1531 which the denial or suspension of the Certificate shall take effect. It shall further state that the Applicant
1532 or Registered Solicitor shall have ten (10) business days from the receipt of the notice of denial or
1533 suspension to appeal the same. The denial or suspension of the Certificate shall be effective no sooner
1534 than two (2) calendar days from the date the notice is sent, unless that suspension is because of exigent
1535 circumstances outlined in Section 17-22-103(34)(C)(4), in which case, the suspension is effective
1536 immediately. The denial or suspension shall remain effective unless and until the order is rescinded,
1537 overturned on appeal, or determined by a court to be contrary to equity or law. Failure to appeal the
1538 suspension of a Certificate automatically results in its revocation.

1539
1540 **17-22-115. APPEAL.**

1541
1542 An Applicant or Registered Solicitor whose Certificate has been denied or suspended shall have
1543 the right to appeal to the City Manager. Any appeal must be submitted by either the Applicant, the
1544 Responsible Person or Entity, or legal counsel for either who: (a) documents the relationship with the
1545 Applicant or Responsible Person or Entity; or (b) is licensed or authorized by the State of Utah to do so,
1546 and makes the assertion of an agency relationship. The following procedures and requirements shall
1547 apply:

1548 (1) Any appeal must be Submitted in Writing to the City Recorder with a copy to the License
1549 Officer within ten (10) business days of the decision from which the appeal is taken. Such appeal shall
1550 describe in detail the nature of the appeal, the action complained of and the grounds for appeal.

1551 (2) Upon request of the Applicant or Registered Solicitor, within one business day, the City
1552 shall make available upon request any information upon which it relied in making the determination to
1553 either deny or suspend the Certificate.

1554 (3) The Appeals Officer shall review, de novo, all written information submitted by the
1555 Applicant or Registered Solicitor to the Licensing Officer, any additional information relied upon by the
1556 Licensing Officer as the basis for denial, suspension or revocation, and any additional information
1557 supplied by the City, Applicant or Registered Solicitor. Any additional information submitted by any
1558 party to the appeal to the Appeals Officer shall be simultaneously submitted to the opposing party. If
1559 desired, any party shall have three (3) business days to submit rebuttal documentation to the Appeals
1560 Officer regarding the additional information submitted by the opposing party.

1561
1562 (4) The Appeals Officer will render a decision no later than fifteen (15) calendar days from
1563 the date the appeal was taken, unless an extension of time is agreed upon by the parties. In the event that
1564 any party to the appeal submits rebuttal information as allowed in Section 17-22-115(3), the fifteen (15)
1565 calendar days shall be extended to include the additional three (3) days for rebuttal.

1566 (a) The denial or suspension of the Certificate shall be reversed by the Appeals
1567 Officer if upon review of the written appeal and information submitted, the
1568 Appeals Officer finds that the Licensing Officer made a material mistake of law
1569 or fact in denying or suspending the Applicant or Registered Solicitor's
1570 Certificate.

1571 (b) If the written appeal and information submitted indicates that the Licensing
1572 Officer properly denied or suspended the certificate of the Applicant or
1573 Registered Solicitor, the denial or suspension of the Certificate shall be affirmed
1574 and constitute a determination that the suspended Certificate is revoked. The

1575 Licensing Officer shall submit his or her affirmance in writing setting forth the
1576 factual reason(s) for the affirmance.

1577 (c) The decision of the Appeals Officer shall be delivered to the Applicant or
1578 Registered Solicitor by the means designated in the completed Application, or as
1579 otherwise agreed upon when the Appeal was filed.

1580 (5) After the ruling of the Appeals Officer, the Applicant or Solicitor is deemed to have
1581 exhausted all administrative remedies with the City.

1582 (6) Nothing herein shall impede or interfere with the Applicant's, Solicitor's, or City's right
1583 to seek relief in a court of competent jurisdiction.

1584

1585 **17-22-116. DECEPTIVE SOLICITING PRACTICES PROHIBITED.**

1586

1587 (1) No Solicitor shall intentionally make any materially false or fraudulent statement in the
1588 course of Soliciting.

1589 (2) A Solicitor shall immediately disclose to the consumer during face-to-face Solicitation;

1590 (a) the name of the Solicitor;

1591 (b) the name and address of the entity with whom the Solicitor is associated; and

1592 (c) the purpose of the Solicitor's contact with the person and/or Competent
1593 Individual. This requirement may be satisfied through the use of the Badge and
1594 an informational flyer.

1595 (3) No Solicitor shall use a fictitious name, an alias, or any name other than his or her true
1596 and correct name.

1597 (4) No Solicitor shall represent directly or by implication that the granting of a Certificate of
1598 Registration implies any endorsement by the City of the Solicitor's Goods or Services or of the individual
1599 Solicitor.

1600

1601 **17-22-117. "NO SOLICITATION" NOTICE.**

1602

1603 (1) Any occupant of a Residence may give notice of a desire to refuse Solicitors by
1604 displaying a "No Solicitation" sign which shall be posted on or near the main entrance door or on or near
1605 the property line adjacent to the sidewalk leading to the Residence.

1606 (2) The display of such sign or placard shall be deemed to constitute notice to any Solicitor
1607 that the inhabitant of the Residence does not desire to receive and/or does not invite Solicitors.

1608 (3) It shall be the responsibility of the Solicitor to check each Residence for the presence of
1609 any such Notice.

1610 (4) The provisions of this Section shall apply also to Solicitors who are exempt from
1611 Registration pursuant to the provisions of this Chapter.

1612

1613 **17-22-118. DUTIES OF SOLICITORS.**

1614

1615 (1) Every person Soliciting or Advocating shall check each Residence for any "No
1616 Soliciting" sign or placard or any other notice or sign notifying a solicitor not to solicit on the premises,
1617 such as, but not limited to, "No Solicitation" signs. If such sign or placard is posted such Solicitor shall
1618 desist from any efforts to Solicit at the Residence or dwelling and shall immediately depart from such
1619 property. Possession of a Certificate of Registration does not in any way relieve any Solicitor of this
1620 duty.

1621 (2) It is a violation of this Chapter for any person Soliciting or Advocating to knock on the
1622 door, ring the doorbell, or in any other manner attempt to attract the attention of an occupant of a
1623 Residence that bears a "No Solicitation" sign or similar sign or placard for the purpose of engaging in or
1624 attempting to engage in Advocating, a Home Solicitation Sale, Door-to-Door Soliciting, or Soliciting;

1625 (3) It is a violation of this Chapter for any Solicitor through ruse, deception, or fraudulent

1626 concealment of a purpose to Solicit, to take action calculated to secure an audience with an occupant at a
1627 Residence;

1628 (4) Any Solicitor who is at any time asked by an occupant of a Residence or dwelling to
1629 leave shall immediately and peacefully depart;

1630 (5) The Solicitor shall not intentionally or recklessly make any physical contact with, or
1631 touch another person without the person's consent;

1632 (6) The Solicitor shall not follow a person into a Residence without the resident's explicit
1633 consent;

1634 (7) The Solicitor shall not continue repeated Soliciting after a person and/or Competent
1635 Individual has communicated clearly and unequivocally his or her lack of interest in the subject, Goods or
1636 Services of the Solicitor;

1637 (8) The Solicitor shall not use obscene language or gestures.

1638

1639 **17-22-119. TIME OF DAY RESTRICTIONS.**

1640

1641 It shall be unlawful for any person, whether licensed or not, to Solicit at a Residence before 9:00
1642 a.m. or after 9:00 p.m. Mountain Time, unless the Solicitor has express prior permission from the resident
1643 to do so.

1644

1645 **17-22-120. BUYER'S RIGHT TO CANCEL.**

1646

1647 In any Home Solicitation Sale, unless the buyer requests the Solicitor to provide Goods or
1648 Services without delay in an emergency, the seller or Solicitor shall present to the buyer and obtain
1649 buyer's signature to a written statement which informs the buyer of the right to cancel within the third
1650 business day after signing an agreement to purchase. Such notice of "Buyer's right to cancel" shall be in
1651 the form required by § 70C-5-103, Utah Code Annotated, 1953, or a current version thereof or any State
1652 or Federal law modifying or amending such provision.

1653

1654 **17-22-121. PENALTIES.**

1655 Any person who violates any term or provision of this Chapter shall be guilty of a Class B
1656 Misdemeanor and shall be punished by a fine of not to exceed \$1,000.00 and/or a jail sentence of not to
1657 exceed six (6) months.

1658

1659 **Section 4. Severability.** If any provision of this Ordinance is declared to be invalid by a court of
1660 competent jurisdiction, the remainder shall not be affected thereby.

1661

1662 **Section 5. Effective Date.** This Ordinance shall take effect immediately upon posting in the
1663 manner required by law.
