

PUBLIC NOTICE PROPOSED FY 2015-2020 FIVE-YEAR CONSOLIDATED PLAN AND FY 2015-2016 ANNUAL ACTION PLAN

Notice is hereby given by West Valley City that the proposed FY 2015-2020 Five-year Consolidated Plan and Annual Action Plan for FY 2015-2016 have been prepared. The Five Year Plan outlines the City's housing and non-housing community development needs and priorities over the next five years. The Annual Plan for FY 2015 outlines how the City intends to expend \$1,168,072 in Community Development Block Grant funds (CDBG) and \$212,943 in HOME Investment Partnerships Program funds (HOME). In addition to the funding sources noted above, the City anticipates the receipt of approximately \$80,332 in program income. In accordance with the federal regulations at 24 CFR, Part 91, West Valley City is required to prepare and submit a Five-Year Consolidated Plan and Annual Action Plan for its Housing and Community Development Programs.

The City is now soliciting public comments on the proposed Five-year Plan & Annual Action Plan, in order to obtain the views of citizens, public agencies, and other interested parties. The plans are available for review and copies may be obtained at the West Valley City Grants Office located at 4522 West 3500 South, West Valley City, Utah 84120. Physical access parking and entrance are located on the north side of the building. Hearing impaired who wish to discuss elements of the plans may call TDD (801)963-3418 in advance, so an interpreter can be provided. The FY 2015-2020 Consolidated Plan and FY 2015-2016 Annual Action Plan contain the following components:

- A. Identification of housing and non-housing community development needs and priorities over the next five years within the City.
- B. Identification of federal and non-federal resources reasonably expected to be made available during the program year to undertake activities identified in the proposed Five-Year Consolidated Plan for FY 2015-2020.
- C. Activities to be undertaken during the FY 2015 program year to address community development and housing needs including the geographic distribution of activities to be completed.
- D. Identification of homeless and special needs activities to be undertaken during the 2015 program year, as a result of activities assisted with such funds, and the benefits to be provided.

The Five Year Consolidated Plan for FY 2015-2020 and the proposed use of funds outlined in the FY 2015-2016 Annual Plan were developed after conducting Citizen Participation committee meetings, holding public hearings, and the review of requests from local communities identifying needs.

Notice is hereby given that West Valley City will hold a public hearing on **May 26, 2015 at 6:30 p.m.** in the City Council chambers of the West Valley City Hall, 3600 Constitution Blvd., West Valley City, Utah, to obtain final comments on the proposed Five Year Consolidated Plan for FY 2015-2020 and the proposed use of funds for FY 2015-2016. An interpreter for hearing impaired persons who wish to attend will be made available without charge upon requests made five (5) days in advance, requests may be made by calling our TDD number (801)963-3418.
